

MATEJ ACCETTO

Matej Accetto studied law at the University of Ljubljana, taking his LL.B. in 2000; he then received an LL.M. from Harvard Law School in 2001 and a Doctorate in Law from the University of Ljubljana in 2006, where he is Assistant Professor (*Docent*) of European Law and chairs the faculty PhD committee. In 2003, he spent five months as a *stagiaire* at the Court of Justice of the European Union. He is also a former Fellow of the Lord Slynn of Hadley European Law Foundation (2003–04), having spent a year in London visiting with UK judges and barristers in order to assess the impact of EU law on the national judiciary. In 2006, he was the Monica Partridge Visiting Fellow at the University of Cambridge, Fitzwilliam College.

Doc. Accetto lectures extensively on EU law and related issues both at the Faculty of Law and other faculties of the University. He also lectures abroad, having offered courses or guest lectures at the Graduate School of the Chinese Academy of Social Sciences in Beijing (China), University of Copenhagen (Denmark), Harvard Law School and Harvard Kennedy School (the United States), Waseda University and Kyoto University (Japan), ISES Foundation in Kőszeg (Hungary), University of Graz (Austria), University of Iceland (Iceland), University of Kaunas (Lithuania), Bihać Law Faculty (Bosnia and Herzegovina) and Franklin College (Switzerland).

He is a member of the national expert group verifying the Slovenian translations of the historical jurisprudence of the European Court of Justice, has served a member of the government-appointed expert team preparing the national mechanism of verifying EU terminology, is coordinating the work of a faculty research programme on incorporating the EU legal terminology into the Slovenian legal system and is presently also involved in a research project on the decision-making process of regular and constitutional judicature.
