**Cilji in kompetence:**

**Objectives and competences:**

Za Evropsko unijo še nikoli ni obstajalo tako kritično obdobje, kar se kaže predvsem v izzivih brexita, v nazadovanju pravne države ter v splošno razširjenemu političnemu nezadovoljstvu glede sedanjega oblikovanja in delovanja Unije. Zdi se, da se EU nenehno sooča s krizo in neenakostjo. Cilj predmeta je vključiti študente v razumevanje in kritično ocenjevanje teh vprašanj.

Fokus prvega dela bo brexit. Preučili bomo dpgajanje pred referendumom in takojšnje posledice referendumu iz leta 2016, vključno s členom 50 in primerom "Miller". Kritično se bomo ukvarjali z vprašanji suverenosti, demokracije, temeljnih pravic, gospodarskega razvoja, vladavine prava in procesa brexit.

V drugem delu bomo preučevanje razširili na širša vprašanja, ki se nanašajo na prihodnost Unije, in na (ne)ukrepanje Unije za naslavljanie teh izzivov. Študenti bodo imeli priložnost pripraviti svoje seminarje o temah prava in politik Evropske Unije, ki se jim zdijo najbolj zanimive ali pomembne.

Ker ta predmet osvetljuje aktualno dogajanje v britanski, srednjeevropski in evropski sferi, se bo seznam literature in diskusije lahko prilagajal najnovejšemu dogajanju.

There has never been such a critical time for the European Union, in light of the challenges of Brexit, rule of law back-sliding, as well as widespread political dissatisfaction with the current design and functioning of the Union. The EU seems to be plagued by crises and inequality. The module aims to engage students in understanding and critically assessing these issues.

The focus of the first term will be Brexit. We will examine the lead up to, and immediate consequences of the 2016 EU Referendum, as well as the Article 50 notification and the Miller case law. We will continue to critically engage with questions of sovereignty, democracy, fundamental rights, economic development, the rule of law and the Brexit process.

In the second term, our scope will broaden to larger issues facing the future of the Union and the actions taken (or not) by the Union to address these challenges. Students will have the opportunity to lead their own seminars on topics of European Union Law and Politics which they find most engaging or relevant to course of European affairs.

As this Module reflects current events in the British, Central European and general European sphere, reading lists and discussions may change to reflect the latest developments.

**Skills**

Conduct original and independent research and critically evaluate current research and advanced scholarship in the subject area; 6. Demonstrate an ability to deal with complex problems based on own research and advance new or critical commentaries on the subject. 7. Understand and apply critical legal methodology.

**Metode poučevanja in učenja:**

Predavanja bodo študentom omogočila interaktivno raziskovanje relevantnih dogajanj v procesu evropske integracije in študije primerov.

Pred vsakim predavanjem bodo študenti prejeli seznam literature. Med predavanji bodo študentje predstavili svoje poglede o dodeljenem branju. Poleg tega jim bodo predstavljene širše teme na predavanjih. Od študentov se pričakuje, da se bodo pripravljali na predavanja in sodelovali v razpravah. Teme, predstavljene v tedenskih predavanjih, bodo podlaga za nadaljnje raziskovanje študentov, branje in pripravo na seminarje in ocenjevanje.

Študenti bodo morali predstaviti argumente samostojno in / ali v skupinah.

**Learning and teaching methods:**

Lectures will provide students with an interactive exploration of the relevant tensions in European integration process and relevant cases.

Prior to each session, students will be given preliminary directed reading. During the sessions, students will present feedback on specific assigned reading and will be introduced to the broad themes of the module. Students will be expected to prepare for the lectures and participate in the discussions, where appropriate, during lectures. Themes introduced in the weekly lectures will form the basis for students to further research, read and prepare for seminars and assessment.

Students will be required to present arguments individually and/or in groups.

#### **Reference nosilca / Lecturer's references:**

Dr. Damjan Kukovec je diplomiral na Pravni fakulteti Univerze v Ljubljani (cum laude, povprečna ocena 9,9), magistriral in doktoriral pa na Pravni fakulteti Univerze Harvard, kjer je osvojil več nagrad za akademske dosežke ter predaval. Med drugim je delal v pravnih službah Evropske komisije, Sodišča EU in Posebnega sodišča za Sierra Leone. Pred Sodiščem Evropske Unije je uspešno zagovarjal številne primere. Objavljal je dela s področja prava EU, mednarodne trgovine in globalnega vladanja, konkurenčnega prava in pravne teorije. Predaval je na Pravni fakulteti Univerze Harvard, na Pravni fakulteti FGV v Riu de Janeiru, na EUI v Firencah in na Pravni fakulteti Univerze v Kentu v Bruslju. Poleg tega je predaval na več drugih univerzah po vsem svetu. Nedavno je začel službovati kot 'Senior Lecturer' (naziv enakovreden izrednemu profesorju) na Middlesex School of Law v Londonu.

Dr. Damjan Kukovec earned his bachelor's degree at the University of Ljubljana School of Law (cum laude, average grade 9,9). Dr. Kukovec earned his master's and doctoral degrees at Harvard Law School, having won several awards for academic achievement. He practiced, among other places, at the Legal Service of the European Commission, the European Court of Justice and at the Special Court for Sierra Leone. He successfully pleaded numerous cases before the European Court of Justice. He has published in the fields of EU law, international trade and global governance, competition law and legal theory. He has taught at Harvard Law School, at FGV Law School in Rio de Janeiro, at the EUI in Florence and at Kent Law School in Brussels and has lectured at several other universities worldwide. He was recently appointed Senior Lecturer (Associate Professor equivalent) at Middlesex School of Law, London.
