Project group<sup>1</sup> of the Faculty of Law, University of Ljubljana invites abstract submissions for a 2-day Global Conference on Artificial Intelligence (AI) and Human Rights. The conference will be held in Ljubljana (Slovenia) on June 13 – 14, 2024.

Any contribution that addresses the human rights' implications of artificial intelligence is welcome. Abstracts for papers must be no longer than 500 words in length and the abstracts for posters should be no longer than 300 words in length.

All abstracts should be submitted by Sunday, 15 October 2023 to: [vasilka.sacin@pf.uni-lj.si](mailto:vasilka.sacin@pf.uni-lj.si) and in cc to [tadeja.urbas@pf.uni-lj.si](mailto:tadeja.urbas@pf.uni-lj.si).

The submission must include the name and title of the author, position, name and address of the current institution of employment, and a short biography of maximum ten lines. Please write the abstract in third person (e.g. "the author believes ..." instead of "I believe ..." and "the article discusses ..." instead of "I will discuss ...").

The selection of presenters will be done by the end of October 2023 and all applicants will be informed accordingly.
