

## MUNLawS Model United Nations Conference Faculty of Law, University of Ljubljana

## **CALL FOR CHAIRS**

Between **11 and 13 November 2022**, the 10th edition of MUNLawS Model United Nations Conference will be held at the Faculty of Law, University of Ljubljana. The organising team thus invites all interested individuals to participate at the conference as **committee directors (chairs)**.

MUNLawS is a leading university-level Model United Nations conference in Slovenia, organised annually by the Department of International Law at the Faculty of Law, University of Ljubljana. It is aimed at high school and university students as well as young professionals. So far, 9 conferences have been organised and were attended by more than 1 000 delegates from more than 40 countries.

An important role of the committee director includes but is not necessarily limited to:

- a. preparation of a study guide for the delegates' preparation for the simulation on the selected topics,
- b. moderation of the debate/simulation in the assigned committee in accordance with the Rules of Procedure,
- c. assessing the performance of the delegates in the committee and allocation of awards.

Spots are available in the following committees of the 2022 edition of MUNLawS:

- a. Security Council (university level) 2 spots for university applicants,
- b. Human Rights Council (university level) 2 spots for university applicants,
- c. European Council (university level) **2 spots** for university applicants,
- d. North Atlantic Council (university level) 2 spots for university applicants,
- e. International Court of Justice (university level) 2 spots for university applicants,
- f. OSCE Court of Conciliation and Arbitration (university level) **2 spots** for university applicants,
- g. Security Council (high school level) **1 spot** for high-school applicants, **1 spot** for university applicants,

- h. Human Rights Council (university level) **1 spot** for high-school applicants, **1 spot** for university applicants,
- i. North Atlantic Council (high school level) **1 spot** for high-school applicants, **1 spot** for university applicants.

All applicants must cumulatively meet the following mandatory requirements:

- a. At least CEFR B2 oral and written proficiency in English,
- b. citizenship or permanent residence status of EU/EEA member states, Switzerland, United Kingdom, Albania, Bosnia and Herzegovina, Montenegro, North Macedonia or Serbia,
- c. ability to travel to Slovenia for the duration of the conference,
- d. not being older than 27 years of age.

## The university applicants must meet one of the following criteria:

- a. being a university student in the academic year 2022/23,
- b. the applicant's university status will be temporarily paused in the academic year 2022/23, but not for the duration of more than 1 academic year.

The following university applicants shall have the advantage in the selection procedure:

- a. Previous experiences with organising and/or chairing at least one MUN conference,
- b. attending at least 2 MUN conferences in the past,
- c. receiving an award at one of the MUN conferences attended,
- d. previous participation at MUNLawS conferences as a chair, organiser or staff member,
- e. previous experience with organising or participating at European Youth Parliament Sessions or similar youth simulation events.

The high-school applicants must meet the following criteria:

- a. being at least fourth-grade high-school student in the school year 2022/23,
- b. previous experiences with organising and/or chairing at least one MUN conference.

The following high-school applicants shall have the advantage in the selection procedure:

a. having received an award at one of the previous editions of the MUNLawS Conferences or other MUN events.

All the mandatory requirements and advantage elements are to be proven with authentic documentation.

The organiser will provide to the selected candidates:

- a. help with finding an accomodation for the duration of the conference (if necessary),
- b. lunch and coffee breaks during all three days of the conference,
- c. conference materials,
- d. conference briefings,
- e. certificate of participation.

Deadline for application is **15 May 2022 at 23:59** via the online application form available at <a href="https://www.munlaws.com/chair-application">www.munlaws.com/chair-application</a>. The selected individuals will be invited to an online interview with the organisers. The final decision on the selected candidates should be made by 30 May 2022. The selected candidates will be notified about the decision to the e-mail provided in the application form. The rejected candidates will be notified about the decision to the e-mail provided in the application form

The organising committee reserves the right to invite certain individuals to participate in the selection procedure. The organising committee reserves the right to invite certain applicants to fill-in the vacant spots. The committee also reserves the right to repeat the selection procedure. Final decision of the committee shall not be appealable.
