## Young Property Lawyers' Forum 2022 Call for Abstracts – Extended Deadline

The Young Property Lawyers' Forum (YPLF) 2022 invites junior researchers in the field of property law to submit abstracts for its annual conference, to take place virtually in collaboration between the University of Iceland, KU Leuven, Union University School of Law, University of Camerino and University of Glasgow.

The YPLF is an informal network of junior property law researchers, both PhD candidates and those within 5 years of having obtained their doctorate. The YPLF aims to bring property law scholars together from around the world and enable them to discuss their work with each other and with more experienced researchers. The conference provides an informal setting for young researchers to discuss innovative ideas and research in the area of property law, and to seek support in solving problems and improving their research, both in skills and in content. However, those who do write a paper will have the opportunity to publish the paper in a special issue of an international journal.

Places are limited. The selection criteria are the quality of the research and its originality. We also strive to ensure a diversity of represented legal systems. The YPLF encourages informal discussion, so applicants are encouraged to send in abstracts on work in progress. We will send out confirmations by **6<sup>th</sup> May 2022**. No participation fee applies.
